

DISENROLLMENT ACKNOWLEDGEMENT

--I have been informed that I am being processed for possible disenrollment from the NROTC Program. I understand that as I have entered into an obligated status (beginning of sophomore year and receiving benefits) or entered the program via BOOST or Fleet-Input, I have incurred an obligation to the U.S. Government.

--I understand that, if approved by the Secretary of the Navy, I may be allowed an option as to how to satisfy the obligation I have incurred by signing my NROTC Service Agreement and an enlistment contract with the following two exceptions:

--I further understand that if I am a Four-Year National Scholarship recipient and am disenrolled during my junior or senior year I must serve on active duty for a period not less than two years.

--If I am a Three or Two-Year Sideload Scholarship recipient and disenrolled during my senior year, I must serve on active duty for a period of not less than two years.

1. Immediate call to active duty for a period not less than two years as an enlisted member in the U.S. Navy or Marine Corps. My tour of active enlisted service would commence immediately upon approval of such a request by the Secretary of the Navy and completion of appropriate processing from my NROTC unit.
2. Immediate call to active duty for a period not less than one year if I am BOOST/Fleet-Input and in my Freshman year or not less than two years or the greater amount time remaining on my original enlisted contract if I am obligated to the NROTC Program (beginning of the sophomore year naval science classes and receiving benefits). Options 3, 4, 5, or 6 are applicable to me only if I am obligated to the NROTC Program and have less than two years remaining on my original enlisted contract at the beginning of the sophomore year naval science classes.
3. Deferment of active enlisted service to complete my undergraduate education at my current college or university. If I continue enrollment in my current university/college at my own cost after disenrollment from my NROTC unit, my active enlisted service (outlined in 1 above) may be deferred until my graduation or disenrollment from my university/college.
4. Deferment of active enlisted service to complete my undergraduate education at a university or college which differs from my current institution. Upon notification that my disenrollment and active duty enlisted service has been approved by the Secretary of the Navy, I have 90 days in which to gain acceptance and become enrolled in a university of my choice. I must apply to the Chief of Naval Personnel (Pers 834) or Commanding Officer, Marine Corps Recruiting Command (ON) if I choose this option. If my request is approved by Pers 834 or ON, my active enlisted service will be deferred until graduation or disenrollment from my designated university/college.

NOTE: If I choose either of the above deferment options, I understand that deferment of my active duty will not be authorized past July 1st of the year following that which my NROTC class would have graduated. Additionally, I understand that while my deferment is in effect, I will be assigned to commanding Officer, Enlisted Personnel Management Center (EPMAC Code 70) (Navy Option). A Marine option disenrollee's Record Book is held at ON and orders will be generated at a later date. It will be my responsibility to contact EPMAC or ON at any time my status will be my responsibility to contact EPMAC or ON at any time my status as a student or my address should change.

5. Recoupment of educational expenses in lieu of active enlisted service. I understand that if my request for recoupment of educational expenses in lieu of active enlisted service is approved by the Secretary of the Navy, I will be required to sign an additional page 13 entry acknowledging my indebtedness to the government. My indebtedness to the U.S. Government includes all educational expenses (tuition and applicable fees) paid on my behalf while enrolled in the NROTC Program. I understand this includes those educational expenses paid during my freshman year. Upon acknowledging my indebtedness, I understand that I will be discharged from the naval service and my case will be transferred to DFAS-Denver for collection. DFAS will contact me and initially I will receive paperwork that states I must repay the debt in three year, however, I may contact DFAS and arrange a payment schedule and for an excessive debt I may be given up to ten (10) years to pay the debt. Interest will be charged at the current rate at the time of the debt. Interest will be charged at the current rate at the time of the debt. Interest will be charged at the time of my disenrollment. Further, I understand that if I remain a full-time student I may request a deferment of debt collection until after I graduate.

6. The Secretary of the Navy may waive the requirement for active service and recoupment. I understand that certain reasons for disenrollment may allow for the waiving of both active service and recoupment.

7. After thoroughly reviewing the various options outlined above, if my disenrollment is approved, I request the following option to satisfy the obligation that I have incurred:

- Immediate call to active duty.
- Deferment of active duty in order to complete my education at my current institution.
- Deferment of active duty to complete my education at another institution. I will submit my written request for deferment to Pers 834 or ON.
- Recoupment of education expenses in the amount of \$ _____ in lieu of active enlisted service.
- I have been informed by my unit that due to the nature of my disenrollment, a waiver of both active duty and recoupment may be authorized in my case.

8. I understand that, barring the most extreme circumstances, my request, once approved, is irrevocable.
